Message from the President

I hope you are having a wonderful spring and early summer season. We have finally received life-giving rain and Mother Nature has bounced back with the beauty of springtime in the form of wildflowers that we have not seen in quite some time. It's interesting how, in nature, everything waits for the right time to do what it is programmed to do. Wildflowers are mostly springtime bloomers. Wouldn't it be odd to see bluebonnets in August or December? They know when their time is and they bloom every spring — sometimes a lot, sometimes a little — but always in the spring. In Ecclesiastes, Solomon talks about the seasons of life. Those seasons ring as true today as they did when he penned those words.



Ecclesiastes talks about seasons of life for people, but there are also "seasons of life" in businesses, churches and ministries like ours. There are businesses, churches and ministries that are no more. Do you remember Montgomery Ward? Sears? Foley's? There are many others you can name. How about the Crystal Cathedral? It was a longtime church founded by Robert Schuller, and it is no more. You may pass by church buildings that are now community centers or may just be in disrepair. The common theme in all these instances of closing/failure? Lack of foresight or flexibility.

LSM has gone through many seasons of life: College campus to a rest home which was all private pay or charity care, rest home to nursing home with Medicaid, added memory care, added independent living in six different steps, added assisted living, added Pot O' Gold, downsized nursing and assisted living, added Hospice, added Personal Assistance Services, partnered with the Bosque County Health District in the QIPP Program. What does our next season hold? We are looking to expand independent living once again. Do the negative ramifications from COVID in the form of low census and staffing challenges in Sunset Home and Heckmann Assisted Living ever abate and go back to "normal," or is this the new normal? How do we survive? Across the country our industry has been hit hard and confidence in long-term care facilities has been eroded. COVID gave great incentives to bring care services into elders' homes, which impacts long-term care and assisted living facilities.

Our goal of course is to survive to continue to serve seniors in our community. That has been our goal for 69 years. The season we are in is a challenging one, no doubt. It remains to be seen how this season ends and the next one begins. Like the founders and keepers of our ministry over the years, our key to survival is looking forward and being flexible to solutions to our challenges. In that endeavor, pray for us and our Board as we navigate the obstacles ahead.

Consider Giving from Your Traditional IRA

Make a difference today and save on taxes! It is possible when you support Lutheran Sunset Ministries through your traditional IRA.

You can give any amount (up to a maximum of \$100,000) per year from your traditional IRA directly to a qualified charity such as Lutheran Sunset Ministries, your congregation and/or the ministries you specify without having to pay income taxes on the money. Gifts of any value \$100,000 or less are eligible for this benefit and you can feel good knowing that you are making a difference. This popular gift option is commonly called the IRA charitable rollover, but you may also see it referred to as a qualified charitable distribution, or QCD for short.

Why consider this gift?

- If you are required to take minimum distributions, you can use your gift to satisfy all or part of your RMD obligation.
- You pay no income taxes on the gift. The transfer generates neither taxable income nor a tax deduction, so you benefit even if you do not itemize your deductions.
- Since the gift doesn't count as income, it can reduce your annual income level. This may help lower your Medicare premiums and decrease the amount of Social Security that is subject to tax.
